# Membership

Karen Greig

Dave M – would multi-year mean fewer scholarship donations?

Ron B – suggested no discounts for multi-year member premiums

Dave M & Karen --- agreed to work-up a plan and share with board via e-mail

Jack p – membership is a vehicle to connect/campaign

Wayne – feels like our numbers are pretty high for a small org.

Dave – anecdotes – membership is good value. How do we keep fluid/relevant/dynamic going forwards.

Recurring? Longer term i.e. 5 years?

Dick B – does a couple count as a single membership. Karen said sometimes. Therefore our actual numbers might be higher.

Haley – what is our average age? How do we connect younger people?

Jack P – Survey, have we ever asked members about GCHS? Does Board wish to survey our members? Do we want to grow membership?

Ron B – suggest survey at renewal time? How are we reaching/recruiting members?

Dave – allows us to test effectiveness of our programming/pubs/outings

Donelle – draw-in younger people using a paper completion a la Pecos? Wayne asked symposium committee to put this info on the lists of ideas.

Wayne – asked Haley why she wished to be a member? She is fascinated with history/GC/learning/

Dick B – AZNM Hist convention – no one had heard of us. How do we increase our profile? Echoed by John S.

Jack P – work on calendar of events around GC and N AZ that we can attend with GCHS marketing materials. Develop a ToteBox with banner, tablecloth, stickers, brochures etc

#### Treasurer

Brian Blue

Transfer of process from Amy H meant auditing all transactions 2012-present. Found through audit that cash on hand did not change, but there were some material shifts in some accounts and some years. For example, there was a material shift from Memberships into Scholarship.

Income increase in 2016 due to symposium. Sitting on good reserves of cash/funds.

38k total cash balance 4k in scholarship Lee Albertson fund 1956 fund

scholarship fund – gave out three scholarships but still have 4K symposium – net 11.5K

Lee Albertson fund – 2 deposits in 2016. Unrestricted. How should it be handled? Keep separate?

Wayne – offer as a cash award to best speaker at symposium? Retroactively?

Dave – not in favor of cash? Perhaps help with symposium presenter expenses instead? Ron B – use funds to fund handing out of published proceedings? Informed that publishing plans takes into account a certain number of 'free' copies.

Jack P – use to underwrite some expenses to help low income presenters come to symposium?

Brian – agree that we hold the \$\$ for the symposium. Brian will write up proposed 'conditions' of funds and submit to the Board for approval through e-mail.

Restrictions? Who decides where it goes?

Wayne – donors are relatives of people who died. Considered unrestricted. Thinks it should stay with 1956-group as the families get more involved.

Dave M – sees the group gaining traction over next few years, but then waning as their group ages.

Brian – agrees that the board is responsible for the spending. Brian will write up proposed 'conditions' of funds and submit to the Board for approval through e-mail.

>\$250 gifts – IRS rules indicate that such a gift has to be acknowledged. This will be handled by the Treasurer. Formal policy and procedure will follow.

President will continue to write and send the letters/notes to contributors of \$50 or more. Formal policy and procedure will be developed for consideration and approval by the Board via e-mail.

Dick B – did we file a 990? Brian said we did file a postcard notification with IRS – very simple.

Brian – works on procedure/criteria concerning approval and paying of bills etc
